

RESOLUTION NO. 2009-1

A RESOLUTION OF THE BOROUGH OF CENTRE HALL, CENTRE COUNTY, PENNSYLVANIA, AUTHORIZING THE EXPENDITURES FROM THE FUNDS COLLECTED BY THE BOROUGH OF CENTRE HALL FROM THE FIRE TAX FOR: THE SEMI-ANNUAL PAYMENTS DUE ON REAL ESTATE PURCHASED - FEBRUARY \$3,500.00 AND AUGUST \$3,500.00; THE ANNUAL PAYMENT DUE ON TRUCK PURCHASED - JULY \$7,000.00; TWO (2) QUARTERLY INSURANCE PAYMENTS; AND THE FIREMENS WORKMEN'S COMPREHENSIVE PAYMENT FOR THE CENTRE HALL FIRE COMPANY PURSUANT TO THE DECEMBER 6, 1999 COOPERATIVE AGREEMENT BETWEEN CENTRE HALL BOROUGH, POTTER TOWNSHIP AND THE CENTRE HALL FIRE COMPANY.

WHEREAS, the Borough of Centre Hall (Borough) is a municipal corporation organized under the Laws of the Commonwealth of Pennsylvania; and

WHEREAS, the Borough of Centre Hall, Potter Township and the Centre Hall Fire Company entered into a Cooperative Agreement dated December 6, 1999 in which a committee was established by which purchases of equipment and accessories from the fire tax collected by the Borough of Centre Hall and Potter Township would be approved as mutually agreed upon; and

WHEREAS, Centre Hall Borough desires to expend two (2) \$3,500.00 from the fire tax monies on a semi-annual basis as its share of the purchase price of said real estate; \$7,000.00 from the fire tax monies on an annual basis as its share of the purchase price of truck; two (2) quarterly insurance payments from the fire tax monies as its share of the insurance; and the workmen's comprehensive payment from the fire tax monies as its share of the workmen's comprehensive payment for the Centre Hall Fire Company.

NOW, THEREFORE, be it resolved and it is hereby resolved by authority of the same as follows:

1. Centre Hall Borough Council hereby approves the expenditure of two (2) \$3,500.00 from the fire tax monies on a semi-annual basis as its share of the purchase price of said real estate; \$7,000.00 from the fire tax monies on an annual basis as its share of the purchase price of truck; two (2) quarterly insurance payments from the fire tax monies as its share of the insurance; and the workmen's comprehensive payment from the fire tax monies as its share of the workmen's comprehensive payment for the Centre Hall Fire Company.

2. This Resolution approving said expenditure is adopted pursuant to paragraph 5 of the December 6, 1999 Cooperative Agreement.

3. That all prior Resolutions or Ordinances, or parts thereof inconsistent herewith are hereby repealed.
